Fast Track Capacity building Programme Report

Date: - 24th February 2009 to 1st March 2009

Number of Participants: - 21

Type of Participants: - Block Programme Manager under National Rural Health Mission.

Introduction:-

PHRS has conducted a 6days residential capacity building programme for district health planning and management system for the block programme manger for the 5th batch at hotel Madhuban Raipur . 21 Block coordinators from 13 district participated in the training, the training was inaugurated by Dr. Anthony Director of STATE HEALTH RESOURCE CENTRE Raipur Chhattisgarh, one the key note adress he is highlighted the importance of the capacity building programme & narrated the expected outcome by the end of the programme from each of the participant.

Objective of the programme :-

- *Understanding on NRHM Goal & Objectives.*
- *Understanding on the importance of Public Health and to ensure proper plannin & implementation.*
- *To build capacity of block manager & other stakeholders to understand the importance of district health plan & management system at block level.*

Day wise Activities: 1st Day 24th February 2009,

Introduction round:-

All the participants introduced themselves with their qualification & expectation with reference to beginning of the joining at their respective block. This round has facilitate by Dr. Kamlesh Jain & Dr. Megha Khobragady,

Interaction with BPM: -

A discussion on the role & responsibility of the BPM on what they have done, what was their thought before joining was Facilitated by Mrs Sulakshna Nandi & Dr. Kamlesh Jain

Pretest:-

After discussion with BPM a pre – test was organized to estimate the level of participants. It facilitated by Suraj Baghel & Dr. Megha Khobragadey

Goals of Public Health: - This session has taken by Mrs Sulakshana Nandi, she explained about public health, and importance of the public health with reference to Bhole committee, Alma Ata Declaration and Millenium Development goals.

After Lunch break

Dr. Kamlesh Jain took a session on the Goal of NRHM, he elaborated on NRHM programme with an example of best practice of J.S.S. Bilaspur, through an interaction with the participants he highlighted the needs of health service provider and department .the outcome stressed on , good behavior of service provider, complete treatment, Proper diagnosis of diseases. God environment, out of pocket expenses should not be done etc. He said that NRHM is an umbrella programme where so many programme are included , it is flexible in nature. He urged the BPMs to make at least 5 -10 Gram panchayat full function with good indicator .

2nd Day 25th February

Day 2nd started by recap of 1st day activities by the participant after that a short discussion on IPHS standards for CHC,PHC & sub health centre with government guideline . facilitated by Mrs Sulakshna Nandi, Suraj Baghel.

Mr. Sanjay sammadar has taken a session on District Health planning, He explained the importance of block health planning for district & district health planning for the state. He also said that BPMs can play an important role for the planning. In this session all the points were address which are

- Back ground
- Situational analysis.
- Objectives
- Strategy.
- Activities
- Measurable indicator
- Budgeting

Dr. Saurabh Jain (State consultant NLEP/WHO) has taken a session on Leprosy Eradication programme in Chhattisgarh; he explained sign & symptoms of leprosy for understating of BPMs. It is discussed, bhawarpur PHC of Mahasamund is most affected, Leprosy is important in district action plan.

Mr. Avinash Lumba (senior programme coordinator SHRC) updated on the MITANIN programme & its structure in the context of district health planning. Mitanin is playing an important role to make healthy “Para, Villages and Gram Panchayts” He also took a session on Village Health & Sanitation committee. Formation of committee, Members, authority, role of board member. He describe the Swasth Panchyat Yojana and 32 health indicators which is covering in the Swasth Panchayat Yojana through a PowerPoint presentation. The session was very interactive .

Discussion on Field visit:- All the participants divided in 5 groups and visited place such as Community Health Centre Tilda, Primary Health Centre Urla Raipur, Sub Health Centre Silyari Raipur, VHSC – Datreng village, JSY/Mitanin – Parastari village. Every group was given the tasks through a format. Day was concluded by 7.30 pm. Facilitated by PHRN team.

3rd Day 26th February 2009

Day was started by recap of 2nd day after that Dr. Ramani took a session on Maternal health, it was an interactive session. The dimension covered are

Social,

Economical,

Medical,

Health facilities / systems

The above dimension have a direct implication on maternal health Dr. Ramani explained the cause of maternal death . she also focus on the antenatal care, Intra natal care, Pare natal care, danger sign she explain the death rate which are.

- 50% maternal death happening within 24 hours of delivery (Post natal).*
- 25 % death during pregnancy (Prenatal).*
- 25 % death during 1-42 days of delivery*

She suggested every BPMs Should know, how to take B.P. , they should find at least 2 case study on maternal health in a month , BPM should know ,how many B.P. instrument/Weigh Machine are available, and how many in working condition. It is the important work of BPM.

After Lunch : Field visited by all the participants .

4th Day 27th February 2009

Dr. Anthony (Director of SHRC) took a session on child health, he elaborated the strategies for child survival and health in the district plan, He highlighted on the cause of child death, Neonatal mortality and he stressed on ,

The public health strategies for child survival

- 1. Community health worker programme.*
- 2. Quality out reach programme*
- 3. Behavior Change communication*
- 4. Better maternal health care especially at child birth.*
- 5. Institutional care for the sick neonatal*
- 6. Reduction /prevention of Malnutrition.*
- 7. Immunization including vitamin A*

All those point were described in this session. he said that BPMs should ensure the monthly action plan where everything should be specific (like date of visit , place ,time ,vaccination day , immunization day etc). BPM should make special team for immunization , they should visit the village where immunization coverage is poor in the last three month and check the register, interact with the community , know the cause & why.

The session on Jeevan deep samiti & Hospital reforms was taken by Ms Peuli Mazumdar and Mrs. Anupama Tiwari. Introduction to BCC & its incorporation in district action plan was facilitated by Mr. Sameer Garg. He explain the importance of BCC, IEC, Planning, Activities, implementation of the programme and its out come through BCC Grid Chart.

At the ends of the day field visit experience was shared by the each group through chart paper presentation.

5th Day 28th February 2009

5th day was started with a session on Tuberculosis problems in the Chhattisgarh & its control in district health plan was addressed by Dr. Megha khobragade. Malaria problem and its control were defined by Dr. Jaipraksh . The problems of HIV/ AIDS in Chhattisgarh & its control was elaborated by Dr. Meeta Jain (CGSACS). The session on the training strategy and ensuring outcomes from the training programme was taken by Smt. Sulakshna Nandi. The session on the topic of convergence was facilitated by Mr. Sameer Garg. He explained with an example of AWW, Mitanin, & ANM .

6th Day 1st March 2009

6th day started with the session on Health Equipment Management System which was taken by Mr. Purussotam Saini (HEMS), he interact with all the participants and took information about availability of equipment in the block level CHC & PHCs. He explained to the BPMs on the health equipment management system at block level. He said that all the equipment should be made ready and functional & it should not be dumped in unused place.

Post lunch

Post training assignment and post training formative evaluation proforma were given to them. Feedback form was collected from the participants.

Valedictory function started at 4.00 pm where Dr Anthony (Director of SHRC) & Mr. Uriya Nag (SPM-NRHM) Chhattisgarh were the chief guests. Three participants gave verbal feedback about the training , justified the need of an induction training, They said that they have learnt about NRHM, BPM role & responsibilities and block prgramme management system, they committed that they'll put their best

input to improve IMR &MMR situation finally they gave vote of thanks to SPMU, PHRN team and resource person. Dr. Megha Khobragadey & Mr. Suraj Baghel wish the participants for their best performance. After the feed back Chief guest Dr. Anthony & Mr. Uriya Nag delivered motivational speech and distributed the certificate. Vote of thanks was delivered by Smt.Sulakshna Nandi & Dr. Megha Khobragade . TA/DA was settled by 6.00 pm.
